The New Hampshire Food Bank is excited to offer the Nutrition Pantry Program (NPP) to our agency partners! Through this program, we are able to support our agency network and their clients with an integrative approach to nourish all, regardless of socioeconomic status. The Nutrition Pantry Program (NPP) provides a noninvasive process for implementing practical, client-centered strategies for a healthfocused environment in all types of food distribution. The program offers six key areas to focus on with support from resources, trainings, and connection. NPP is for pantries of all types and sizes, plans are tailored to fit your pantry, and it is no cost to participate!

#### **Sharing Food**

You hopefully received the following notice in a letter during the month of September. This is a reminder regarding sharing of food and products acquired from the NH Food Bank. It is in violation of the NHFB contract and the Feeding America contract to share NH Food Bank food with non-network agencies, including other food pantries, schools and organizations that are not partnered with the NH Food Bank. This also includes sharing food received from partnering grocery stores that donate to your agency through the Fresh Rescue program.

We have been made aware of organizations around the state that have approached NHFB partner agencies to receive food or to order items from our organization via our website and resources. NHFB food may not be shared with any organization that is not a member agency of the NH Food Bank.

If you are approached to order or share food with an agency and are unsure if they are partnered with the NHFB, please reach out and we can confirm their membership status. Sharing food with in-network NHFB member agencies is fine and is within Feeding America and NHFB requirements.
